Every Concert Sweepstakes September 25, 2021

Official Rules

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER OR WIN. VOID OUTSIDE PA, NJ AND DE AND WHERE PROHIBITED.

- 1. ELIGIBILITY: The Every Concert Sweepstakes (the "<u>Sweepstakes</u>") is open only to entrants who are legal residents of Pennsylvania, New Jersey or Delaware, 18 years of age or older as of the date of entry. The following persons are not eligible to enter or win: employees of Comcast Spectacor Events, LLC ("<u>Sponsor</u>") and its parents, affiliates and subsidiaries and advertising and promotion agencies and Prize Providers (as defined below) and the immediate families (spouse, parents, siblings and children and their respective spouses, regardless of where they reside) and members of the households, whether or not related, of each of the above.  - B. complete and deposit the entry form which includes your name, address, telephone number, email address and date of birth, at the designated location at the Philly Tailgate Games (held at the Wells Fargo Center, Philadelphia, PA on September 25, 2021) during the Entry Period

LIMIT ONE (1) ENTRY, PER PERSON, REGARLESS OF THE METHOD OF ENTRY. Sponsor's computer will be the official timekeeper for all matters related to this Sweepstakes. Additional entries beyond the specified limit will be void. Entries generated by script, macro or other automated means and entries generated by any other means which subvert the entry process will be void. Each entrant must fully complete and submit all non-optional data requested on the entry form to be eligible. Incomplete and/or inaccurate entries are void. No entries will be acknowledged or returned. Proof of submission will not be deemed to be proof of receipt by Sponsor.

3. DRAWING: Entries must be received during the Entry Period to be eligible for the drawing. One (1) potential winner will be drawn at random on or about September 25, 2021, from among all eligible entries received. Sponsor reserves the right to delay the drawing. The potential winner will be notified via email and/or telephone (in Sponsor's discretion). The potential winner must respond to email or voicemail notification within 48 hours, or he/she will forfeit the Prize (as defined below) and, at Sponsor's sole discretion and time permitting, an alternate potential winner will be drawn at random from among all remaining eligible entries. DESCRIPTION OF PRIZE: One (1) prize (the "Prize"): The Prize consists of two (2) tickets to each concert taking place at the Wells Fargo Center in Philadelphia, PA for one year, commencing on October 1, 2021 and ending on September 30, 2022 (Approximate Retail Value ["ARV"] of the Prize: \$8,184). The ARV of the Prize may fluctuate based on seat location and booking of additional concerts. For concerts with more than one performance, tickets will only be awarded for one performance (exact performance to be mutually agreed upon, subject to availability). The Prize is awarded "as is" with no warranty or guarantee, either express or implied by Sponsor. Sponsor shall have no responsibility or liability for cancellations, delays, or any other change by any company or person providing any element of the Prize (each a "Prize Provider") due to reasons beyond Sponsor's control, and is not responsible or liable for any expenses incurred as a consequence thereof.
