

## **TERMS OF SERVICE**

**EFFECTIVE DATE: January 17, 2024**

These Terms of Service (“Terms”), are a legal agreement between you and Comcast Spectacor, LLC and its subsidiaries, including, without limitation, Spectrum Arena Limited Partnership, CS Philadelphia Lacrosse Team, LLC, Comcast Spectacor Events, LLC and FPS Rink, L.P. (“Comcast Spectacor,” “we” or “us”) governing your access to and use of the mobile applications, websites and online services that Comcast Spectacor owns and/or operates and that link to these Terms (collectively, the “Platform”). The terms “you” and “your” when used in these Terms means any user of the Platform. Please read the Terms carefully before using the Platform. Using the Platform indicates that you accept and agree to be bound by the Terms. Do not use the Platform if you do not accept the Terms.

Please see our [Privacy Policy](#) for information on how we process your personal information.

By using the Platform, you are representing and warranting that: (a) you are accepting and agreeing to these Terms on behalf of yourself or the entity that you represent in connection with the use of the Platform; (b) you have the right, authority and capacity to accept and agree to these terms on behalf of yourself or the entity that you represent; (c) you are at or above the legal age of majority in your jurisdiction of residence; (d) you own or have sufficient authorization to use the computer, mobile device, technology or other device you use to access the Platform (collectively, “Device”); and (e) you will access and use this Platform in accordance with these Terms.

**THE DISPUTE RESOLUTION/ARBITRATION PROVISION OF THESE TERMS INCLUDES AN AGREEMENT TO MANDATORY ARBITRATION, WHICH MEANS THAT YOU AGREE TO SUBMIT ANY DISPUTE RELATED TO THE PLATFORM TO BINDING INDIVIDUAL ARBITRATION RATHER THAN PROCEEDING IN COURT. IF YOU WANT TO OPT-OUT OF THIS MANDATORY ARBITRATION AGREEMENT, THE DISPUTE RESOLUTION/ARBITRATION PROVISION BELOW DESCRIBES THE PROCEDURES YOU MUST FOLLOW TO DO SO. THE DISPUTE RESOLUTION/ARBITRATION PROVISION ALSO INCLUDES A CLASS ACTION WAIVER, WHICH MEANS THAT YOU AGREE TO PROCEED WITH ANY DISPUTE INDIVIDUALLY AND NOT AS PART OF A CLASS ACTION. THESE TERMS ALSO INCLUDE A JURY WAIVER.**

### **CHANGES TO THE TERMS OR TO THE PLATFORM**

Comcast Spectacor may change or modify the Platform or the Terms at any time. Updated Terms of Service will be posted on our Platform with the effective date. Such changes, revisions, or modifications shall be effective immediately upon being posted. Any use of the Platform by you seven (7) days after we post changes to the Terms constitutes your acceptance of those changes.

Comcast Spectacor reserves the right, in its sole discretion, to restrict, suspend, or terminate your access to and use of the Platform, with or without prior notice. Otherwise applicable sections of the Terms shall survive termination. Comcast Spectacor also reserves the right to seek all remedies available at law and in equity for violations of these Terms. Upon termination, you must cease all use of the Platform.

### **MOBILE DEVICES**

To access any mobile websites, applications or other services available through the Platform, you must: (a) have any carrier or communications services necessary to download content, and (b) pay service fees, if any, associated with any such access. In addition, you must provide all equipment and software necessary

to connect to the Platform. You are responsible for ensuring that your equipment and/or software does not disturb or interfere with the Platform's operations. If any upgrade in or to the Platform requires changes in your equipment or software (including the operating system for your Device), you must effect these changes at your own expense.

## **REGISTRATION AND PASSWORD**

The Platform may permit or require you to register by providing accurate and complete personal information such as your name and e-mail address prior to permitting access to certain services available through the Platform. You acknowledge and agree that you will update this information to keep it accurate and current. It is your responsibility to give us current, complete, truthful and accurate information and to keep the information that you provide to us up to date. We cannot and will not be responsible for any problems or liability that may arise if you do not give us accurate, truthful or complete information or you fail to update the information you give us. You also may be asked to select a password. Your password is personal to you, and you may not allow any others to use the combination of your e-mail address and your password under any circumstances. You acknowledge and agree that you are responsible for maintaining the confidentiality of your registration information and password, for any charges, costs, expenses, damages, liabilities and losses we incur or may suffer as a result of your failure to do so and for all uses of your password. In addition you are responsible for controlling access to any PCs, mobile devices, or other end points that you allow to store your password, or on which you enable a "Remember Me" or similar functionality ("Activated Device"). Accordingly, you agree that you will be solely responsible to Comcast Spectacor for all activities that occur under your Platform accounts, including the activities of any individual with whom you share your Platform account or an Activated Device, and will be responsible for any breach of these Terms caused by these activities. If you become aware of any unauthorized use of your password or of your account, you agree to notify Comcast Spectacor immediately at [termsofservice@comcastspectacor.com](mailto:termsofservice@comcastspectacor.com). To protect your privacy, Comcast Spectacor recommends logging out of the Platform after each visit, when you are using a public or shared PC, mobile device, or other end point.

You are solely responsible and liable for any use of the Platform or any other activity or conduct in connection with the Platform by any others who use the combination of your e-mail address and password, unless and until you notify us that your account may have been compromised, misappropriated or improperly taken or used by another party. You agree to immediately notify us if you become aware of or believe there is or may have been any unauthorized use of your account or any other need to deactivate your account due to security concerns. You may have the ability to deactivate your registration (if any) on the Platform, by emailing customer support at [termsofservice@comcastspectacor.com](mailto:termsofservice@comcastspectacor.com).

## **USER CONTENT**

You are fully responsible for all User Content that you provide to us or others.

**Your License to Us.** By submitting User Content, you grant us and our designees a royalty-free, irrevocable, perpetual, non-exclusive, worldwide, fully sub-licensable, transferable, license to publish, reproduce, distribute, display, perform, edit, adapt, modify, translate, create derivative works, make, sell,

offer for sale, export, and otherwise use and exploit your User Content (or any portion thereof) in any way that we want and in any form, media, or technology now known or later developed. You hereby waive any moral rights you may have in your User Content in favor of Comcast Spectacor and any of its designees. You represent that you have obtained all necessary permissions necessary to grant us those rights, including from any person identified in or implicated by your submission (including those shown in photographic content), and, in the case of minors, also from their parents or legal guardians, as appropriate.

**No Obligation to Publish.** We are not obligated to publish, review, transmit, or use your User Content. Comcast Spectacor is not in any manner endorsing any User Content that it may publish or post on the Platform and cannot, and will not, vouch for its reliability.

**Liability for User Content.** Comcast Spectacor is not responsible for any User Content and has no duty to monitor User Content. You use any information contained in or derived from User Content at your own risk. ## **PROHIBITED CONTENT AND ACTIVITIES**

You may not access or use, or attempt to access or use, the Platform to take any action that could harm us or any person or entity (a “person”), interfere with the operation of the Platform, or use the Platform in a manner that violates any laws. For example, and without limitation, you may not:

- Obtain or attempt to gain unauthorized access to other computer systems, materials, information or any services available on or through the Platform;
- Use any device, software, or routine to interfere or attempt to interfere with the proper working of the Platform or any activity conducted on the Platform or attempt to probe, scan, test the vulnerability of, or breach the security of any system, device or network;
- Circumvent, reverse engineer, decipher, decompile, disassemble, decrypt, or otherwise alter or interfere with (or attempt, encourage, or support anyone else's attempt to engage in such activities) any of the software comprising or in any way making up a part of the Platform. This section applies to any dispute you have with Comcast Spectacor, unless the dispute involves rights to your, Comcast Spectacor's, or our licensor's intellectual property.

**Location and Governing Law.** These Terms are governed by, and must be construed in accordance with, the laws of the United States and the Commonwealth of Pennsylvania, as applicable, without giving effect to their principles of conflicts of law. By using the Platform, you waive any claims that may arise under the laws of other states, countries, territories or jurisdictions. You consent and submit to the exclusive jurisdiction of the Federal or State Courts located in Philadelphia, Pennsylvania, in connection with the enforcement of these Terms.

**Notice of Dispute.** For any problem or dispute that you may have with Comcast Spectacor, you acknowledge and agree that you will first give the relevant Comcast Spectacor entity an opportunity to resolve your problem or dispute. This includes you first sending a Notice of Dispute, which is a written statement that sets forth the name, address, and contact information of the party giving it, the facts giving rise to the dispute, and a proposed solution. You must send any Notice of Dispute by U.S. Mail to Comcast



Spectacor at 3601 South Broad Street, Philadelphia, PA 19148, Attn: General Counsel. You then agree to negotiate with Comcast Spectacor in good faith about your problem or dispute. This should lead to resolution, but if for some reason your problem or dispute is not resolved satisfactorily within sixty (60) days after Comcast Spectacor's receipt of your written description of it, you agree to the further dispute resolution provisions below.

**Small Claims Court.** You may litigate any dispute in small claims court in the Commonwealth of Pennsylvania or in your own county of residence, if the dispute meets all the requirements to be heard in small claims court. You may litigate in small claims court whether or not you negotiated informally first.

**Binding Arbitration.** If you and Comcast Spectacor do not resolve any dispute by informal negotiation or in small claims court, any other effort to resolve the dispute will be conducted exclusively by binding arbitration as described in this section. You are giving up the right to litigate (or participate in as a party or class member) all disputes in court before a judge or jury. Instead, all disputes will be resolved before a neutral arbitrator, whose decision will be final except for a limited right of appeal under the Federal Arbitration Act. Any court with jurisdiction over the parties may enforce the arbitrator's award.

IF APPLICABLE LAW DOES NOT ALLOW BINDING ARBITRATION TO APPLY TO YOU, THE ABOVE PROVISION AND ALL OTHER PROVISIONS OF THESE TERMS WILL APPLY TO YOU TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW.

**Class Action Waiver.** Any proceedings to resolve or litigate any dispute in any forum will be conducted solely on an individual basis. Neither you nor Comcast Spectacor will seek to have any dispute heard as a class action or in any other proceeding in which either party acts or proposes to act in a representative capacity. No arbitration or proceeding will be combined with another without the prior written consent of all parties to all affected arbitrations or proceedings.

IF APPLICABLE LAW DOES NOT ALLOW A WAIVER OF CLASS ACTION PROCEEDINGS TO APPLY TO YOU, THE ABOVE PROVISION, AND ALL OTHER PROVISIONS OF THESE TERMS WILL APPLY TO YOU TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW.

**Arbitration Procedures.** Any arbitration will be conducted by the American Arbitration Association (the "AAA") under its Commercial Arbitration Rules. You agree to commence arbitration only in your county of residence or in Philadelphia, Pennsylvania. Comcast Spectacor agrees to commence arbitration only in your county of residence. You may request a telephonic or in-person hearing by following the AAA rules. In a dispute involving \$10,000 or less, any hearing will be telephonic unless the arbitrator finds good cause to hold an in-person hearing instead. The arbitrator may award the same damages to you individually as a court could. The arbitrator may award declaratory or injunctive relief only to you individually, and only to the extent required to satisfy your individual claim. Further, unless all affected parties agree otherwise, the arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or group proceeding. If a court decides that applicable law precludes enforcement of any of this subsection's limitations as to a particular claim for relief, then that claim (and only that claim) must be severed from the arbitration and may be brought in court.

**Claims Or Disputes Must Be Filed Within One Year.** To the extent permitted by law, any claim or dispute under these Terms must be filed within one year in small claims court, or in an arbitration proceeding. The one-year period begins when the claim or Notice of Dispute first could be filed. If a claim or dispute isn't filed within one year, it's permanently barred.

**Right to Opt Out Of Arbitration.** IF YOU DO NOT WISH TO BE BOUND BY THIS ARBITRATION PROVISION, YOU MUST NOTIFY COMCAST SPECTACOR IN WRITING WITHIN 30 DAYS OF THE DATE THAT YOU FIRST RECEIVE THESE TERMS BY EMAILING [TERMSOFSERVICE@COMCASTSPECTACOR.COM](mailto:TERMSOFSERVICE@COMCASTSPECTACOR.COM) OR BY SENDING MAIL TO COMCAST SPECTACOR, 3601 SOUTH BROAD STREET, PHILADELPHIA, PA 19148-5290, ATTN: LEGAL DEPARTMENT/ARBITRATION. YOUR WRITTEN NOTIFICATION TO COMCAST SPECTACOR MUST INCLUDE YOUR NAME AND ADDRESS AS WELL AS A CLEAR STATEMENT THAT YOU DO NOT WISH TO RESOLVE DISPUTES WITH COMCAST SPECTACOR THROUGH ARBITRATION. YOUR DECISION TO OPT OUT OF THIS ARBITRATION PROVISION WILL HAVE NO ADVERSE EFFECT ON YOUR RELATIONSHIP WITH COMCAST SPECTACOR OR THE DELIVERY OF SERVICE(S) TO YOU BY COMCAST SPECTACOR. IF YOU HAVE PREVIOUSLY NOTIFIED COMCAST SPECTACOR OF YOUR DECISION TO OPT OUT OF ARBITRATION, YOU DO NOT NEED TO DO SO AGAIN.

**Future Changes to the Arbitration Provision.** If Comcast Spectacor makes any changes to the Dispute Resolution/Arbitration section of these Terms (other than a change to the address at which Comcast Spectacor will receive notices of dispute, opt-out notices or rejections of future changes to the Dispute Resolution/Arbitration section), you may reject any such change by sending us written notice within 30 calendar days of the change to: [termsofservice@comcastspectacor.com](mailto:termsofservice@comcastspectacor.com). It is not necessary to send us a rejection of a future change to the Dispute Resolution/Arbitration section of these Terms if you had properly opted out of the arbitration and group litigation waiver provisions in this Dispute Resolution/Arbitration section within the first 30 calendar days after you first accepted these Terms. If you have not properly opted out of the arbitration and group litigation waiver provisions in this this Dispute Resolution/Arbitration section, by rejecting a future change, you are agreeing that you will arbitrate any dispute between us in accordance with the language of this Dispute Resolution/Arbitration section, as modified by any changes you did not reject.

This section survives expiration or termination of these Terms for any reason.

## **GENERAL**

**Integration and Severability.** These Terms constitute the entire agreement between Comcast Spectacor and you, superseding any prior or contemporaneous communications and proposals (whether oral, written or electronic) between you and us. In the event any provision of these Terms is held unenforceable, it will not affect the validity or enforceability of the remaining provisions and will be replaced by an enforceable provision that comes closest to the intention underlying the unenforceable provision.

**No Waiver.** Our failure to enforce any provisions of the Terms or respond to a breach by you or other parties shall not in any way waive our right to enforce subsequently any terms or conditions of the Terms or to act with respect to similar breaches.

**Assignment and Binding Effects.** You must not assign these Terms or any rights or obligations herein without the prior written consent of Comcast Spectacor and any attempted assignment in contravention of this provision is null and void and of no force or effect. Comcast Spectacor has the right to assign these Terms, and any of its rights or obligations herein. These Terms are binding upon each party and its respective successors, heirs, trustees, administrators, executors and permitted assigns.

**Separate Terms and Conditions.** In connection with your use of the Platform, you may be asked to consent to policies or terms and conditions in addition to these Terms. Please read these supplemental policies and

terms carefully before making any use of such portions of the Platform. Any supplemental terms will not vary or replace these Terms regarding any use of the Platform, unless otherwise expressly stated.

**Termination; Modification.** We reserve the right to modify, edit, delete, suspend or discontinue, temporarily or permanently the Platform (or any portion thereof) and/or the information, materials, products and/or services available through the Platform (or any part thereof) with or without notice. You agree that we shall not be liable to you or to any third party for any such modification, editing, deletion, suspension or discontinuance of the Platform. The obligations that you have to us under these Terms shall survive termination of (a) the Platform, (b) any use by you of the Platform, (c) any User Content on the Platform, or (d) these Terms.

**For IOS and Android Users.** You acknowledge that these Terms are an agreement between you and Comcast Spectacor only, and not with the app store where you downloaded the Comcast Spectacor app (for iOS users, the App Store operated by Apple Inc. (“Apple”) or for Android users, the Google Play store operated by Google Inc. (“Google”). Apple or Google are not liable for any damages related to the Platform. Apple and Google shall each be a third-party beneficiary of these Terms with respect to this paragraph.
